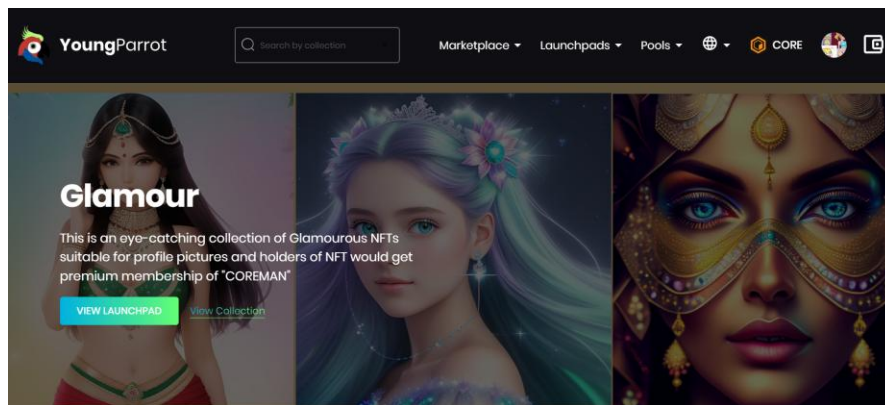


Fig 1 Glamour Collection listed at Young Parrot

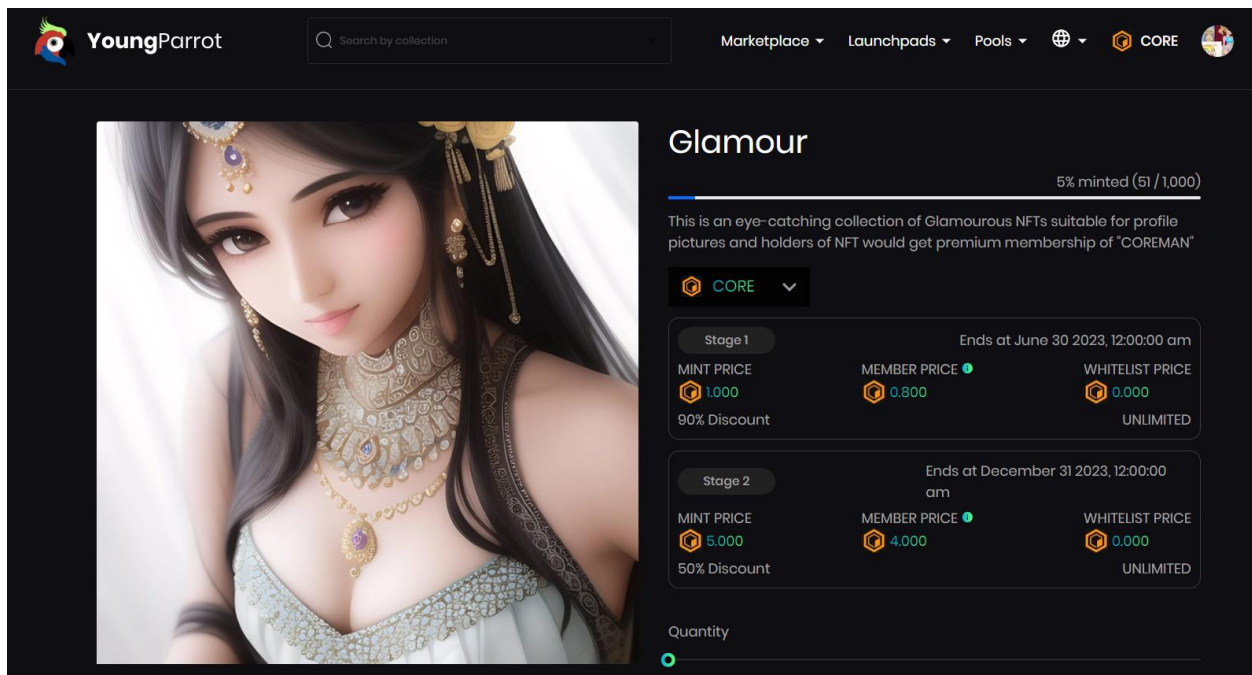


Fig 2 Glamour collection in minting mode
